## HRM Task Force Updates



As you may already know, OMD heard your concerns about HRM report delivery issues (i.e., high volume of reports, fax suppression, etc.). To address them, the OMD HRM Task Force brought together key system partners and decision makers (Ontario Health, hospitals, EMR vendors, HIS vendors, OMA, OHA) to find solutions to decrease the report burden.

The Task Force has now completed all its meetings.

- The Advisory Circle's last meeting was on April 13, 2023.
- The Sending Facility Standards Working Group's last meeting was on April 6, 2023.
- The EMR Usability Working Group's last meeting was on November 8, 2022.

The Task Force has supported the creation of the following reports: Current State Assessment, Sending Facility Service Standards, EMR Usability Recommendations and a proposed Execution plan. Members will incorporate feedback in a final review cycle. Once finalized and approved by the Task Force membership, these reports will be published on our [HRM Experience Improvement Task Force](#) page.

We are continuing to meet with key stakeholders to highlight the great work of the Task Force and to promote the final recommendations. This month we will be meeting with the Section on General & Family Practice (SGFP) Executive, and next month, with the Chief Medical Information Officer (CMIO) of the Ontario Collaborative.



### Updated Diabetes Outpatient Care Flow Sheet



The [Canadian Cardiovascular Harmonized National Guidelines Endeavour](#) (C-CHANGE), a nationally endorsed guideline process that targets primary health care practitioners, has produced an updated [Diabetes Outpatient Care Flow Sheet](#) for clinicians in collaboration with Diabetes Canada. This flow sheet aligns with leading practices and includes the existing billing incentive for primary care. The information on the flow sheet is all evidence-based and published in the clinical practice guidelines from Diabetes Canada and C-CHANGE.

The updated flow sheet is currently integrated with Accuro® EMR. If you use another certified EMR, please ask your EMR vendor about accessing this updated version.



### Are You Moving? HRM Needs to Know Where You Are!

Just like the post office, HRM needs to know where to deliver your reports. Moving? Switching Internet providers? Changing your Internet plan? Choosing a new EMR? These scenarios could potentially mean a change to your IP delivery address, disrupting your HRM feed and stopping your reports from sending sites. HRM only delivers to locations it trusts, so **don't forget to notify OMD** at [support@ontariomd.com](mailto:support@ontariomd.com) when making a change. We need a **minimum of 7 business days** from the time we receive your **complete** request with a **valid** IP address to ensure you don't experience any service interruptions.
