### Taking Action on Hospital Reports



OMD understands the frustration you may have when it comes to receiving digital hospital reports. That's why we brought together clinicians, Ontario Health, hospitals, EMR vendors, HIS vendors, the OMA, and the OHA to discuss solutions that can improve your report delivery experience. Like the post office, which only delivers letters to you, and doesn't write the letters, HRM only delivers reports to you. It doesn't write the reports.

Next month, OMD will publish the recommendations of the HRM Task Force in four documents: **Current State Assessment, Sending Facility Service Standards, EMR Usability Recommendations and a proposed Execution Plan**. The OMA, in partnership with OMD, has developed user friendly referral templates and [EMR stamps](#) with instructions for use in the Accuro® and TELUS PSS EMRs. Updated [referral letter templates](#) are available in Microsoft Word on the OMA website (login required).

In accordance with the [CPSO Virtual Care Policy](#), physicians are reminded that they must use professional judgement to determine whether virtual care is appropriate each time its use is contemplated.

### **Successful Clinical Systems Renewal in the North Western Toronto OHT**

OMD partnered with the [North Western Toronto Ontario Health Team](#) (OHT), Humber River Family Health Organization, Norfinch Family Health Organization, and [WELL Health](#) for the OHT's Clinical Systems Renewal project, funded by Ontario Health. The project transitioned 70 providers from 11 separate instances of WELL Health's OSCAR Indivicare EMR to two instances of OSCAR Pro. Thanks to the work from this partnership, approximately 53,000 patient records can be securely accessed by multiple providers to support the delivery of comprehensive care.

## Important Reminders



### Are You Moving? HRM Needs to Know Where You Are!

Just like the post office, HRM needs to know where to deliver your reports. Moving? Switching Internet providers? Changing your Internet plan? Choosing a new EMR? These scenarios could potentially mean a change to your IP delivery address, disrupting your HRM feed and stopping your reports from sending sites. HRM only delivers to locations it trusts, so **don't**

**forget to notify OMD** at [support@ontariomd.com](mailto:support@ontariomd.com) when making a change. We need a **minimum of 7 business days** from the time we receive your complete request with a valid IP address to ensure you don't experience any service interruptions.
