Opioid High-Risk Co-prescribing Recall

I4C Indicator MED-OPI-006: Opioid High-Risk Co-prescribing Recall v 1.0

Category: Medication Management/Opioids

Purpose:

This indicator is used to identify patients potentially at risk due to co-prescribing of opioids with another specific type of medication: benzodiazepines, z-drugs, pregabalin, and gabapentine.

Source:

Based on UK National Health Service Safety Indicators Specification published in 2019.

Base Population:

All patients with an Active demographic status with at least one opioid medication currently prescribed along with at least one benzodiazepine, z-drug, gabapentine, or pregabalin medication currently prescribed.

Indicator Segments:

<u>Current opioid prescription with current benzodiazepine prescription:</u> Count of patients with at least one current opioid prescription documented AND WITH at least one current benzodiazepine prescription documented.

<u>Current opioid prescription with current z-drug prescription:</u> Count of patients with at least one current opioid prescription documented AND WITH at least one current z-drug prescription documented.

<u>Current opioid prescription with current pregabalin prescription:</u> Count of patients with at least one current opioid prescription documented AND WITH at least one current pregabalin prescription documented.

<u>Current opioid prescription with current qabapentine prescription:</u> Count of patients with at least one current opioid prescription documented AND WITH at least one current gabapentine prescription documented.

A *current opioid prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

A *current benzodiazepine prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

A *current z-drug prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

A *current pregabalin prescription* is a medication identified by the brand or generic name containing 'pregabalin' that is a current (not discontinued) medication.

A current gabapentin prescription is a medication identified by the brand or generic name containing 'gabapentin' that is a current (not discontinued) medication.

Suggested Indicator Use:

Physician or Practice use of this indicator is to identify or recall patients co-prescribed opioids with another specific medication (benzodiazepine, z-drug, pregabalin, gabapentine) which may present potential patient risk.
